Exhibitor Terms and Conditions

The SPCA Serving Erie County reviews applications for exhibitor participation to ensure that all items and services align with our mission and do not directly compete with our sponsors.

1. The SPCA will provide you with a specific 12' x 12' space on blacktop. Vendors are required to bring their own tables, chairs, and tent if desired. Though a tent is not necessary, we strongly encourage you to bring a 10' x 10' tent if you own one. The SPCA is unable to rent tents for vendors and SPCA employees or volunteers cannot assist in setting up your tent.
2. We plan to have 1,000 people and 350 dogs participate in the event. Please be prepared if you plan to distribute any samples, coupons, or other promotional materials.
3. All individuals must be 21 years of age or older. This includes ticket purchaser, vendors and exhibitors, staff and volunteers must be 21 or older on the event grounds.
4. If you wish to partake in the food and drink samples, you must purchase a General Admission ticket (\$50/each) and check in at the Registration Tent.
5. You may arrive at the SPCA shelter as early as 1 p.m. to set up your space. **Vehicles will be parked across the street after set-up.** Please have your space ready and open for business by 4 p.m. at the latest. Please do not close or dismantle your booth prior to 8 p.m.
6. Donation jars and selling pets of any kind on or near the event grounds is strictly prohibited. In keeping with our mission to protect, care for, and advocate for animals, we ask that you contact Genna Mages to discuss animal products for approval.
7. The SPCA requires all vendors to provide proof of insurance naming the "SPCA Serving Erie County" as Additional Insured (Form: ACCORD 25 2016-03). For a home-based business, a signed Hold Harmless Agreement may be used as an alternative. Also acceptable is a Homeowner's Binder or Declaration Page stating \$500,000 worth of liability coverage.
8. As a vendor, it is your responsibility to collect and submit appropriate sales tax to West Seneca, the County of Erie, and the State of New York.
9. You are not authorized to "sublet" your booth space in whole or in part.
10. The event is held rain or shine!
